## 1. GENERAL INTRODUCTION

The ISN Continuing Medical Education (CME) Program aims to advance the sharing and dissemination of knowledge by supporting faculty presenting at local and regional nephrology-related events in low, lower-middle-, and upper-middle-income countries. ISN-supported speakers are approved by the ISN, which sponsors the travel expenses of up to 3 experts who supplement local speakers. If applicable, and in addition, ISN may sponsor (a) Nurse Ambassador(s) to deliver talks that are pertinent to the region and address issues related to allied health professionals in nephrology. ISN-supported speakers participate in the events on a voluntary basis and do not receive honorarium. They are dedicated to sharing their knowledge with doctors, specialists, and nurses.

Every year, the ISN CME Program brings essential teaching and training to some 14,000 doctors and healthcare practitioners.

Since 1993, the ISN CME Committee, as well as the ISN Regional Boards, have supported event organizers in building suitable scientific programs matching the needs of the local nephrology community. These events are organized by either ISN affiliated national, regional societies or credible scientific/medical societies.

The goals of the ISN CME Program are (1) to stimulate the interest of the local and regional nephrology communities in expanding their programs and developing relationships with experts who can provide additional mentoring and support; and (2) inspire young professionals to become part of the ISN community and contribute to our advocacy, research, and training activities.

The ISN CME Program does not provide CME credits. Obtaining accreditation from official bodies is the sole responsibility of the event organizers.

### IMPORTANCE OF REGIONAL EVENTS

The ISN CME Program supports integrated proposals that cover a wider geographical region in order to maximize impact. Regional events are platforms where nephrologists should strategically discuss the available local/regional resources and the best way to expand nephrology services. Promoting a dialogue amongst the nephrology communities in a region is particularly helpful.

## 2. APPLICATION GUIDELINES

### ELIGIBILITY CRITERIA

- ***ISN membership:***  
It is a key requirement that both the event organizers and proposed speakers are active and ISN Full members in good standing.
  - Event organizers must be ISN Full members for at least **one (1) year** prior to the year of application.
  - Proposed speakers must be ISN Full members for at least **three (3) continuous years** prior to the year of application.

- **Event's Country Classification as per World Bank**

Applications are open to events that are held in low-, lower-middle-, and upper-middle-income countries according to [World Bank classification](#).

- **Scientific program & target audience:**

A formal scientific program of the event must be provided (even if preliminary) and target an attendance of at least 100 participants (preferably with an international/regional scope). Classroom type courses for in-house faculty are not considered eligible. A one-day meeting can be incorporated into a national or international conference of nephrology. A stand-alone event should have a program of at least 2 full days.

The incorporation of sessions and activities for other kidney health professionals (nurses, technicians, etc.) in the scientific program is highly encouraged.

- **Speakers:**

Although speakers may be suggested by event organizers, the ISN CME Program Committee will take such suggestion under advisement only and will have the final word on the sponsored speakers who may be different than the ones proposed by the organizer.

Relevant topics and needs of the region must be clearly addressed in the application.

Selected and sponsored speakers are preferably local and regional.

ISN-supported speakers give at least 2 lectures per event (minimum of 25 minutes each), participate in other activities such as visits to centers, hospital rounds, informal meetings with trainees, etc., and agree to provide feedback on the relevance and impact of the event to the ISN, as well as report on the status of the nephrology in the region. Meetings with representatives of the Health Ministry of the region are highly encouraged. Speakers are active and engaged ISN full members and act as ambassadors of ISN's vision, mission, and goals. ISN staff will provide slides on ISN which are required to be presented at the event. ISN-supported speakers are voice and play a key role in promoting the ISN network and activities to the local communities.

The ISN CME Program Committee will give priority consideration to applications for support for regional events as well as from event organizers involved in other ISN Programs (Educational Ambassadors, Sister Renal Centers, Regional Training Centers, etc.). Event organizers are strongly encouraged to involve neighboring regions in their program.

The ISN CME Program will not provide support for industry employees or industry-planned programs.

## HOW TO APPLY

Applications for the CME Program are accepted all year long. However, **applications must be submitted 3-6 months prior to the planned start date of the event.**

**Applications must be submitted 3-6 months prior to the planned start date of the event via [programs.theisn.org](https://programs.theisn.org)**

- Application form
- Scientific program of event
- Budget allocation to event and breakdown of costs
- CV of proposed speaker(s)
- Post-event report of previously supported events (if any).

### 3. SUPPORT

The ISN CME Program offers support to event organizers by:

- Providing advice in establishing a suitable scientific program developed to meet the needs of the local/regional nephrology communities;
- Selecting expert speakers in relation to the scientific program;
- Funding the travel of the selected speakers;
- Involving ISN Regional Boards or other Supporting Groups for advice and support.

In order to remain international and geographically equitable, the ISN cannot provide support for the same events for more than 2 consecutive years at a time.

### 4. TOPICS

The ISN CME Program Committee will consider applications on any nephrology topic, but strong preference will be given to topics that align with ISN's strategic priorities. The scientific value of the event should be evident, as reflected by the selection and status of the speakers and their expertise in the field, as well as the quality of the scientific content. Event organizers are expected to develop programs specifically related to relevant local challenges and clinical program development rather than generic nephrology teaching.

ISN is interested in improving the knowledge base and profile of nurses and allied health professionals in low-, lower-middle-, and upper-middle-income countries, and of increasing their awareness of ISN initiatives. ISN will, therefore, consider favorably the requests to provide support to nurse speakers who will present at the event in question, and at associated nursing or other workshops in cooperation with local nephrology nurse leaders.

## 5. SPEAKERS

### PRACTICALITIES

The CME Program supports the travel of the selected speakers to participate in the events, but accommodation must be covered by the organizers.

- ISN can help speakers in booking the tickets.
- Tickets should be booked at least 30 days in advance to avoid expensive fares.
- The reimbursement request forms must be filled out and submitted (together with electronic tickets and/or scanned copy of all expenses/invoices) within 30 days after the event.
- Expenses items without receipts will not be reimbursed.

Important notes:

- The ISN cannot be held liable for any untoward consequences or risks related to traveling or staying abroad. The responsibility for procuring health/accident and travel insurance remains with the supported speaker. The supported speaker or his/her relatives cannot hold ISN responsible in the event of untoward events or experiences.
- The ISN will not reimburse tickets purchased less than 21 days before travel.

## 6. EVALUATION CRITERIA

The ISN CME Program Committee led by Chair and Deputy Chair, often reaching out to ISN Regional Boards or other Supporting Groups for advice, review, and comment on the applications along the following criteria:

- **Profile of Local organizers**  
Events should be organized by a credible scientific/medical society such as ISN affiliated national, regional societies. Event organizers must be ISN Full members for at least one (1) year prior to the year of application.
- **Scientific quality of the agenda and alignment with ISN's strategic priorities.**  
The scientific program needs to be fully detailed with sessions and topics, and include the speakers' names. The scientific value of the event should be evident. The topic(s) of the event should be in line with ISN's main goals and strategic priorities.
- **Relevance and sustainable impact of the event within the region**  
Event organizers are expected to develop programs more specifically related to relevant local challenges and clinical program development rather than generic nephrology knowledge. Local and regional health needs should be fully described in the application form so to allow the ISN CME Program Committee to have a global overview of the past, present and future actions/challenges of the host country.
- **Selection of speakers and relevance of financial support requested**  
The ISN CME Program Committee takes into consideration the proposed speakers (if any) by the event organizers. Proposed speakers must be ISN Full members for at least three (3) continuous years prior to the year of application.  
  
The ISN CME Program Committee members/reviewers are free to suggest other speakers that they find more appropriate to the relevant topics and needs of the region in question. Local and regional experts are preferred.
- **Target audience**  
The event will be of additional value if it reaches out to early-career professionals, other healthcare providers such as nurses, technicians, etc. It is expected that activities such as workshops directed to these professionals are organized.

- **Budget**  
The event's budget must be fully disclosed including the breakdown of expenses expected by the organizers. This allows the ISN CME Program Committee to weigh the intervention of the ISN CME Program.
- **Sponsors**  
Other sponsors and funding sources must be fully disclosed in the application. This allows the ISN CME Program Committee to check if the event is commercial and it will weigh the intervention of the ISN CME Program.
- **Declaration of Istanbul**  
Event organizers must endorse the principles of the Declaration of Istanbul and ensure that all scientists, presenters, and topics discussed are not in conflict with its principles.
- **Synergies with other ISN programs**  
Applications submitted by [Sister Centers](#) or past [Fellows](#) or in conjunction with an application to the [Educational Ambassadors Program](#) are given some priority consideration and are more inclined to be supported as ISN tries to maximize its local impact.

## 7. REVIEW PROCESS

Each application may take up to 1 month to be reviewed and follows the steps below:

1. Administrative review
  - a. Check if all the necessary documents were submitted and application form is fully and duly completed; applications missing documents or the information requested (such as scientific program, budget, sponsorships, etc. may not be considered);
  - b. Check if eligibility criteria is met.
  - c. Check past support and post-event reports (if applicable).
2. CME Program Committee review
  - a. Each application is reviewed by all the members of the CME Program Committee.
  - b. The CME Program Committee Chair and Deputy Chair make a final decision based on the collected feedback.
3. Further details can be requested to the event organizer at any point of the reviewing process.
4. Applicants are notified of the outcome of their application via official communication from the Program Coordinator.

## 8. PROMOTION OF SUPPORTED EVENTS VIA ISN

The ISN will include the name, short description and logo of the supported event on the ISN website's [Calendar of Events – ISN Stakeholders](#).

## 9. ISN REQUIREMENTS FOR SUPPORTED EVENTS

### ISN VISIBILITY

The ISN will provide successful applicants with a formal acceptance letter and the ISN logo for inclusion on printed and online materials related to the event in question.

Note that the ISN logo should NOT be included on event materials (including the event's website) until AFTER application has been approved and is to be used specifically for the sponsored event only. In addition, the following statement must accompany the logo: ISN endorses promotion of education, not the specific content.

Note that the ISN logo can be included on attendance certificates but NOT CME certificates.

To help promoting the ISN to the event delegates, event organizers and ISN-supported speakers are required to:

- Actively recommend that delegates attending the event join the ISN community and receive the bi-weekly ISN Insight e-newsletter by:
  - Collecting the name, surname, country, and email address of the delegates who agree to receive ISN Insight (in compliance with applicable data protection laws) and providing this list to ISN (Excel spreadsheet);
  - Prominently displaying the hyperlink to the ISN e-newsletter sign-up form on the event's web page: <https://www.theisn.org/subscribe-to-insight/>;
  - Display or print the ISN's e-newsletter sign-up sheet/slide with QR code (provided with acceptance letter).
- Feature the name, disclaimer statement above, and logo of ISN appropriately on all publications of the event and provide copies of all relevant official publications to ISN.
- Provide ISN with a copy of the event pricing table listing the delegate/attendee registration fees.

Organizers of ISN-supported events are also requested to:

- Offer reduced registration fees to ISN members (if feasible)
- Allow the showing of intermission slides about ISN's upcoming programs and activities
- Promote upcoming ISN events, especially the upcoming ISN World Congress of Nephrology (WCN).

For certain events, ISN will contact its organizers to discuss options for promotional or educational activities, such as joint scientific sessions, inclusion of ISN information in the delegates' bags or registration documents, inclusion of an ISN booth or table at the event for announcing ISN's conferences and promoting research, education, advocacy, and membership, and inclusion and promotion of selected proceedings on the ISN Academy (ISN's educational portal). Note that the publication of summaries, presentations, or conference audio-visual material on the ISN Academy requires a separate editorial review and approval process.

## REPORTS

The organizers and supported speakers of the ISN-supported events must submit a post-event report within **3 weeks** after the event.

The post-event report helps ISN assess the benefit and impact of its support. It is also a way for ISN to gather information on the main challenges and barriers for developing nephrology in each region and the role of ISN in present and future challenges.

**Non-submission of such report leads to rejection of ISN support in the following years.**

The ISN welcomes photos, videos, short stories and quotes about the event at any time during or shortly after the event. This greatly helps ISN publish short news article about the event and regional activities as well as share successes and challenges within the global kidney community.

## 10. ANNEX

### ISN CME PROGRAM TRAVEL POLICY

#### FLIGHTS

ISN reimburses Economy Class only with restricted travel fare up to a maximum as stipulated. This should be booked at least 30 days in advance to avoid expensive fares.

The invitation letter to each ISN-supported speaker will include the expected cost of an economy class ticket from the speaker's home region to the region where the event is taking place based on published ticket price ranges. The ISN-supported speaker will be requested not to purchase a ticket above that guide price without prior contact with the Program Coordinator.

Important notes:

- The ISN cannot be held liable for any untoward consequences related to traveling or staying abroad, including those related to Covid-19. The responsibility for procuring health/accident and travel insurance remains with the speaker. The supported speaker or his/her relatives cannot hold ISN responsible in the event of untoward events or experiences.
- The ISN will not reimburse tickets purchased less than 21 days before travel.

#### ISN MAY ALSO COVER:

- Transfers between home, terminal and transit hotels
- Auto mileage at \$0.585/mile tolls and parking
- Normal visa fees
- Tips related to above services.

#### ISN DOES NOT COVER:

- Business class travel for ISN-supported speakers
- First class travel for ISN Executive Committee members
- Honoraria for participation in ISN programs/activities
- Hotel and accommodation expenses
- Meal expenses
- Between meal bar bills
- Room service
- Personal phone calls and fax charges
- Transportation to/from destinations that are not involved in ISN activities.
- Gym or spa fees
- Theatre or entertainment tickets or in-room entertainment
- Rush charges for visa or passport
- Spouse/partner travel expenses
- Valet cleaning and other personal services.

## ISN CME PROGRAM REIMBURSEMENT POLICY

The reimbursement request form together with proof of expenses and financial statement must be submitted **maximum 30 days** after the event takes place. After this time, the ISN will no longer reimburse the expenses. All the documents are provided by the Program Coordinator together with official communication.

- ISN reimbursement forms must be fully and duly completed.
- W-8BEN form for non-US residents.
- W-9 form for US residents.
- Scanned documents are acceptable as well as E-tickets.

### LOST RECEIPT

Receipts must be submitted for each expense. In case of lost receipt, ISN will not reimburse the expense.

The ISN will use foreign currency exchange rates from Oanda Foreign Exchange reference available at [www.oanda.com](http://www.oanda.com). Rates will be calculated on the day of expenditure.

**Expenses must be submitted in the original currency incurred.**
